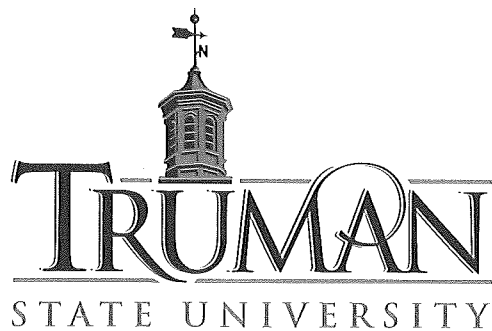

Student Government Resolution 116.035

**A Resolution Creating the 2016-2017 Organizational Activities Fee Review Committee
Sponsored by President JJ Dorrell and Rules ad Hoc Chair Clarissa Todd**

WHEREAS,

- The Student Government is the official governing body of the Student Association and exists to represent the present and long-term best interests of the Student Association in the formulation of University policy and in the fulfillment of the University mission; and
- Each student pays \$45.00 per semester for the Activity fee; and
- From the Activity fee, \$2.00 per semester goes to Student Government; and
- From the Activity fee, \$9.55 per semester goes to the Funds Allotment Council; and
- From the Activity fee, \$26.70 per semester goes to the Student Activities Board; and
- From the Activity fee, \$3.75 per semester goes to the Collegiate Readership Program; and
- From the Activity fee, \$3.00 per semester goes to the Center for Student Involvement; and
- Each student pays \$58.00 per semester for the Athletic fee; and
- Each student pays \$5.00 per semester for the Environmental Sustainability fee; and
- The aforementioned fees are to be reviewed every three years by the Organizational Activities Fee Review Committee (OAF).

THEREFORE BE IT RESOLVED THAT THE STUDENT GOVERNMENT,


- The 2016-2017 Organizational Activities Fee Review Committee shall be established; and
- The membership of the committee shall be comprised of: a chair, three students at large, a Student Government representative, a Funds Allotment Council representative, a Student Activities Board representative, an Athletic Fee Accountability Committee representative, an Environmental Sustainability Fee Accountability Committee representative; and
- The chair only votes if a tie is present between the eight representatives; and
- In addition to its charter to review these fees, this committee shall strive to seek student opinion on the effectiveness and management of the fees; and
- This committee shall publish their fee recommendation report no later than March 25, 2017 so that it may be brought to the following Board of Governors meeting; and

- The chair of the committee shall provide a separate report no later than April 1, 2017 documenting the committee structure and proceedings to be used to establish concrete guidelines for future OAF proceedings.
