 - Prior to cutting these teams, we offered just as many NCAA c. teams as Mizzou does. Now only Mizzou beats us in number of teams in the state of Missouri. WE are in compliance with Title

IX because we offer every sport for women possible in the Great Lakes Valley Conference (GLVC).

- vi. COMM 170 Test Out is never ending. So, we had long discussion last year, and over the summer Mary Shapiro did research and surveys over the summer.
 - 1. Option 1: Run as it currently is, but use professors from all disciplines to judge. Apparently there wasn't interest.
 - 2. Option 2: It would be a paid test out of about \$50 to go in the week before school starts and give a speech before COMM faculty. But this is still run by the faculty. The Comm dept is talking about this tomorrow so please send up all hopes, wishes, desires, etc. that they pass it.
 - 3. We created a committee, but honestly it's still in the hands of the comm dept. You kind of see the harsh reality of serving on committees. The faculty complains about budget cuts and being overworked.
- vii. Symposium: We had another meeting, and they are looking to changing the entire university schedule next fall to revolve around the symposiums. Deanna pulled up a graphic. 11-12 p.m. on Tuesdays and Thursdays for symposiums. There will be some things offered for upperclassmen, or it will be "chapel time" a rest hour across campus, where you could visit professors office hours.

Discussion

- 1. Absence Policy!
 - a. We are trying to consolidate and clarify the absence policy. We have also changed requirements for associate senators and other positions. There is a section about excuse policy, but it doesn't really define anything.
 - i. Nothing has changed in attendance requirements, it's just clearer.
 - b. Questions: Holt: I don't like the unexcused plus five? These are not defined.
 - i. DeWitt: Two unexcused absences necessitate removal? So two retreats?A: I will flag that, because the language needs to be changed.
 - ii. Excuse policy has not been hashed out yet.
 - iii. Schmidt: Should we clearly define them? A: Yes and No; mixed responses on how defined these items should be.
 - iv. Where do we stop or start being understanding? Or do we add an umbrella clause and lower the number of absences?
 - v. Most groups define absence: workplace, organizations; this concept is not new.
 - vi. Wednesday at 7 is Rules Revision, and we will be debating this in front of the body, as well.
