## Student Government Resolution 118.025 A Resolution Formalizing Student Government's Role in Earth Week Sponsored by Jared Kolok, Environmental Affairs Committee Chair; Rachel Holt, External Affairs Chair; and Hannah Wissler, Ethics Justice

## WHEREAS,

- The Student Government is the official governing body of the Student Association and exists to represent the present and long-term best interests of the Student Association in the formulation of the University policy and in the fulfillment of the University mission; and
- Planning for the 2019 Earth Week has taken place in conjunction with the Sustainability Office, Environmental Campus Organization (ECO), and other environmentally focused organizations; and
- The Sustainability Office requested \$728.85 for Earth Week projects and materials from the Student Government's Environmental Sustainability Fee Accountability Committee<sup>1</sup>; and
- The request was approved by the Student Senate on March 31, 2019<sup>2</sup>; and
- Since the approval of the funding, there has been some confusion as to who has authority over Earth Week; and
- According to the Truman State University Student Government's Standing Rules, the Environmental Affairs Committee is responsible for planning and executing Earth Week programming lasting at least three days<sup>3</sup>; and
- The Environmental Affairs Committee has benefited by working with outside organizations, including the Sustainability Office; and
- The Environmental Affairs Committee has, in the past, offered logistical and monetary support to outside organization, often cutting into its own limited budget for the betterment of Earth Week; and

- Supports the past actions of the Environmental Affairs Committee in carrying out logistic and monetary oversight of Earth Week.
