i. Faculty Senate was very interesting! There was some fallout from delaying Dialogues, the main thing we need to focus on is getting the most out of the extra time we have to work on the curriculum!

iii. ## New Business

a. 2019 AFAC Slate of Proposals (Smestad)
i. There is a detailed description on the slate, and the projects highlighted in green are higher priority than the ones in yellow.
ii. Questions

1. Schmidt: For the bullpen project, are we sure this amount is going to be enough?
a. I've talked to Jerry and he has assured me it will be.
2. Schmidt: Is Jerry in support of the bathroom renovations?
a. He said that with that amount of money for baseball/softball projects, it can't be ignored. What is helpful is that the maintenance building is being rebuilt, and it is near the bathrooms, so they might get done. I'm cautiously optimistic.
iii. Discussion
3. Wissler: I would like to see better lighting for the volleyball courts behind Centennial. Other than that, the rest are great projects.
b. First Read: A Resolution Promoting the Visibility of Gender Neutral and Accessible Bathroom Maps (Wimms)
i. We have already created the maps, this is just outlining the timeline of what we did and telling the University to put the maps online.
ii. Discussion

c. Money Motion for Diversity Week (Wimms)

7. Schmidt: Do you think this will be enough food/drink for these events?
a. I'm basing this off of attendance last year, which wasn't super high, so I think so.
8. Holt: Are the cookies gluten-free?
a. Yes!

d. Money Motion for Elections Posters (Wissler)
i. $\quad \$ 200$ for posters. One round for getting people interested to run, one for letting people know how they can vote.
ii. Approved
e. Money Motion for Goof Off Day (Wissler)
i. $\quad \$ 120$ from Purple Friday. Either March 22 or 29, for candy which we've priced out. Yardpong, but Laura doesn't like that
9. Hogan: yard bucket
f. Appropriations Slate (Hogan)
i. There are four things to look at, but technically there are only two applications, because we also have two that we didn't approve. Just a brief synopsis of what the committee thought of all of these: for the Sustainability Office part, we still don't think that it adheres to the ballot language, but we were unable to come to a decision, so we will let the Body decide on that. For the members of SHAG, we felt that because they are going to their conference as group, we will fund them as a group, and not individuals. For the ones we denied: we are not allowed to fund ROTC, if they want to come back as individuals, we can fund them. For club baseball, we found their application to be poorly written, and that they were not very proactive in getting their funding.
ii. Questions
10. Leppanen: A point of clarification - the Sustainability Office is applying through ESFAC for funds, this is not from ESFAC itself.
iii. Motion to split the slate between the Sustainability Office and other items.
11. Motion passes
g. Sustainability Office Slate
i. Questions:
12. Weber: What exactly is the problem with the slate?
a. Costello: It's not really a project, it's just making the Sustainability Office look better.
b. Hogan: If it were phrased as aiming to improve the ongoing projects of the Sustainability Office, it would be more acceptable.
c. Weber: So if the wording were changed to better show that, it would be fine?
d. Hogan: Yes.
ii. Discussion
13. Holt: I think I have the same issue with this, it doesn't look a project aimed at improving campus
14. Schmidt: I see good things and not-so-good things. On the one hand, I can see that the carts would be a good thing. However, putting recycling bin in the office does not seem like part of a project. For example, putting more recycling bins across campus would be a viable project.
15. Hogan: Kyle, correct me if I'm wrong, but I think the bins are supposed to be for campus recycling only?
16. Kolok: Kyle, do you believe this is a project?
a. Yes, I think it allows the Sustainability Office to better work on their other projects
b. Why I ask is that I don't feel it really falls into that category.
17. Schmidt: How much is left of the money we allocated for the Sustainability Office?
a. Weber: I'm not sure, I'm not directly responsible for keeping track of that.
18. Wissler: What happens if the money is not spent?
a. Leppanen: It would roll over
19. Hogan: We created this process for a reason,
20. Kyle: Just a reminder, ESFAC is not applying for this funding, it is the Sustainability Office. A side note to that, we are not funding the Sustainability Office again next year, because of the difficulty of this process.
iii. Slate fails 0-9-5
h. SHAG, ROTC, \& Club Baseball Slate
21. Hogan:
a. SHAG: We thought that we would give them their application fees.
b. Club baseball: again, a lack of communication which led to their failure to get FAC funds.
ii. Questions:
22. Kolok: I notice some discrepancies between the slate and what has been said. Joon said they had a game in Nebraska, thus not having a benefit to Truman. Is that still the case?
a. It is in Nebraska.
23. Holt: Is there a precedent to deny an application if FAC denies a similar one?
a. No.
iii. Discussion:
24. Kolok: I disagree with the Appropriations Committee's decision to reject this application based on the notion that students who travel for events only see benefit for themselves and not for the University. Regardless of whether it is a sporting event or an academic conference, students who go beyond campus represent Truman, and. Especially considering the body's decision to award funding to Donald Rabin for his travel to a national music conference, I feel it is disingenuous to decide that Club Baseball's participation in their event is any less important than his.
iv. Motion to split slate into Club Baseball and other items.
25. Motion passes 9-0-5.
i. Club Baseball Slate
i. Discussion
26. Hogan: I can see Jared's point on sending people out, but I think it's comparing apples and oranges. Donald's application was very clear in how his attendance at
the conference would benefit Truman, theirs was not. The fact is, they failed to meet deadlines for FAC, which why they're here.
27. Holt: I sat in on the FAC hearing, and they definitely cared about putting forth effort in their pitch. I don't think we should disregard them simply because they messed up on the FAC front.
28. Schmidt: A couple of issues: hiring the umpires puts us at a liability, and I'm not comfortable with that. Another thing, we did give them two chances to clearly explain their need, and they failed to do so. I understand they were probably stressed while writing this, but that's the reality.
29. Smestad - I have some concerns, specifically about how they are paying the officials whereas their opponents are not. Also, why are they asking for that much money for all of these games? I would imagine they would not be using four umpires for a game, so this looks they are then only ones paying for umpires.
30. Hogan: This may also have been a failure to communicate on our part, but that was one of our questions, too. They provided no context for how hiring the game officials works.
31. Wissler: The amount per umpire seems reasonable, but it appears that Truman's team is the sole one funding the umpires.
32. Leppanen: I would like to comment on the differences between this slate and Donald Rabin's. The argument for him was that his attendance at his event would elevate the University's prestige. In the case of the club baseball team, them playing their games, away from campus, does not seem to do that.
ii. Slate passes 9-2-3, funding not allotted.
j. SHAG \& ROTC Slate
i. Discussion:
33. Hogan: Point of clarification - we are discussing our decision to fund SHAG, and our decision not to fund ROTC
34. Wissler: Both of these make sense, I think giving SHAG that level of funding is a happy medium.
ii. Slate passes 12-0-2.
