TRUMAN STATE UNIVERSITY STUDENT GOVERNMENT TWELFTH SESSION OF THE 2020-2021 GENERAL BODY October 18, 2020

Called to Order 5:01

- 1) Preliminary Items
 - a) Roll Call
 - **b)** Approval of Minutes
 - c) Gallery Introductions/Business
 - i) Sara Seifert
 - (1) Sent out invitations to many groups on campus to answer questions and address concerns; lots of calls for defunding police, questions for how DPS is run
 - (2) I am your police chief; I am here because of you all, and I cannot do policing at Truman without having a relationship with students
 - (3) Have 10 officers for 5,000 students; we cannot be everywhere at once, but must be able to work with students to help keep campus safe
 - (4) 75-80% of DPS budget is personnel costs; other 30% is operating budget (training, fuel, computer software, repair/updates to uniforms and equipment, and student employees)
 - (5) If you want to have good law enforcement, hiring is important; prospective officers must go through oral interview and a large background packet (including usernames/passwords for social media accounts, psychological exam, doctor's physical, lie detector test, physical examination)
 - (6) TruAlliance started this year; focusing on opening lines of communication and building trust between DPS and student body
 - (7) Goal is to establish proactive communication with student groups (for example, with protests); enhancing meaningful discussions on topics important to students; provide transparency in processes and procedures, and answer students' questions; establish avenues for proactive rather than reactive change
 - (8) Bias-related incidents need to be reported in order for change to happen; allows for patterns to be analyzed; @trumanDPS Instagram and Facebook has information about this, as does Title IX page
 - (9) Holt: Have you discussed safe arrests with the local jail?
 - (a) Seifert: Yes. Two years ago, College Republicans brought in Robert Spencer and local law enforcement met with these individuals; if you wanted to be passive-aggressive or stand your ground, DPS can arrange to have officers pick you up in a wheelchair
 - (10)Alexander: Can you speak to the recent safety-related incidents (tire slashing, parking lot incident)
 - (a) Seifert: Tire slashing incident was on-camera; were able to distinguish three people; had to get statements and estimates to take to court; two juveniles involved were already familiar with the juvenile system and refused to talk, third was an 18-year old male
 - (i) Re: SUB incident, working with female reporter of assault; had her look over a line-up, wondered if she was targeted; unable to pick anyone from the line-up, so continuing to push for information (safe team escorts, etc.)

- (ii) This was the first call we have had in the past 8 years in which someone has been jumped
- (11) Neely: Do you think it would be a good call for DPS to invest in more cameras?
 - (a) Seifert: These would be a deterrent, but there is no one who could monitor them 24 hours a day; would aid in identification after crimes occur; budgets have been slashed due to pandemic, and without some kind of public safety fee, this probably wouldn't happen
- (12)Montúfar: After the tire slashing incident, I also had all my tires slashed at Campbell, and then later my window broken; there were a lot of inconsistencies between the two officers who took my report; also reached out to SA and found it interesting that this hadn't been communicated to ResLife, seemed that there wasn't any procedure to help this communication happen; also felt like I wasn't particularly supported by DPS
 - (a) Seifert: In residence halls, we are very reactive. We would generally notify entire campus if incident met certain criteria; we do have fairly open communication with ResLife; just check in if you have questions about the status of an investigation; do lighting surveys frequently, test all emergency phones on campus
- (13) Montúfar: It seems as though there hasn't been much student engagement with TruAlliance so far. Do you have any strategies for improving this?
 - (a) Seifert: Have been talking with the students who have been coming about reaching out to city, changing time of meetings, working to involve KPD; recently sent an invite to presidents and vice presidents to send representatives from organizations; have gained so much insight from even smaller numbers of students

- (b) Seifert: I understand that there are people who have had bad experiences with police; this is not our department; want to make a difference, one interaction at a time

 - (a) Bates: I am not sure, but the survey also went out to faculty and staff; the decision for the fall was in line with other institutions, but administration is also aware of the added stresses of no break semester; there are certain standards that will likely remain in place, such as certain Union rooms being used as classroom spaces, continued distancing in classrooms, etc.
 - (5) Meyer: I started this semester with two in-person classes, and now only have one. Will there be any protocol in place to stop this from happening?
