 - i) Purinton: Congratulations to Rob! We're super excited to have you on the team and I will be in contact with you shortly.

 - i) Cooper: Rainbow Friday went really well– it was probably the busiest Purple Friday tabling I've ever seen. a) Secretary

5) New Business

- a) A Resolution Opposing a COVID-19 Vaccination Mandate and Acknowledging the Right to Make Personal Health Decisions (Bishop)
- **b)** Bishop: It is my opinion that the Student Government rushed into supporting a vaccination mandate on campus. I believe we should withdraw our support from the American Association of University Professors and acknowledge the student body's right to make personal health decisions.
- c) Myers: Could you go over the process of reading resolutions?
- **d)** Smith: Resolutions are generally a two-week process– during the first read, there is a lot of discussion and the resolution is edited. Then, the next week, it can be brought to a vote after a second reading.
- e) Wuennenberg: How did you calculate your number is bullet point five?
 - i) Bishop: So I looked at the percentages of hospitalizations in Adair County and went through each corresponding age group. I'm thinking about adding some sort of graphic or diagram to make it more clear.
- **f)** Cooper: Do you plan on adjusting the resolution for the second reading for the response bias of the survey that the University sent out?
 - i) Bishop: Yes, I'm open to any sort of discussion about this. Truman State University did not publicly extrapolate the results of that survey and I think that they should have done that, considering only fifty-some percent of people responded.
- **g)** Woods: I have a quick question about some of the sources you cited. Could you explain to me how higher ed would be a good example of that for your evidence.
 - i) Bishop: I did not look too far into that source, but it seemed to be a news document talking about students at risk of deregistration of students in New York as a cause of vaccination mandates.
- **h)** Smith: I wanted to mention that members of our gallery are perfectly welcome to contribute to this discussion.
- i) Bryce: Is there a way that we can see the resolution and follow along?
 - i) Smith: There is a tab on our website for meetings and you will find our agenda there. If you scroll to the bottom of the agenda, you will find the link to the resolution.
- j) Wuennenberg: I'm really not that educated on this issue, but at the moment my inclinations are to support this resolution. However, I would recommend a few changes before I can fully support it. I would echo what Tori said about the sources

and I would recommend that you use different and original sources. I would also agree with Kennedy's point about survey bias on campus. I'll bet you that the majority of unvaccinated students would not fill out the survey in the first place. To my knowledge, Truman *does* require vaccinations for standard things, so I would appreciate it if you could address that before I consider supporting.

- i) Bishop: Yes I will absolutely work with the first two points. As far as the other required vaccinations, I believe that the data suggests that COVID-19 is not as serious of an illness as the illnesses that required vaccinations prevent.
- ii) Bates: MMR and meningitis are required.
- **k)** Woods: Vaccines are really important. I have a lot of chronic illnesses and I do not think we are in a position to acknowledge that vaccinations are not just a personal health decision. When you're going through and acknowledging specific points, I think it's important to look at the bigger picture because pandemic statistics are very difficult to read. Specific numbers and specific sources need to be held in the back of your mind. I appreciate your concern for the wellbeing of the student body.
- Montúfar: I think that most of the concerns about this resolution center around a lack of communication about this resolution. As far as the extrapolation of the COVID-19 vaccine survey, there is a committee working on that and it's still happening and data is still being gathered on that.
- **m)** Montúfar: The University is really interested in pushing vaccination numbers, but they are not interested in disenrolling students because of their vaccination status.
- **n)** Montúfar: My last comment would be that you should be working with the Health, Wellness, and Safety Committee.
- **o)** Bishop: Bringing a resolution that directly opposes the resolution that Health, Wellness, and Safety put out a few weeks ago was not on the top of my list, but I understand how it would be beneficial to communicate with them before bringing a resolution to the entire body.
- **p)** Bono: I would like to talk about the last point. Health, Wellness, and Safety can advocate for the general welfare of students.
- q) Rowley: Through a basic Google search, you can find that a majority of college students support a vaccination mandate against COVID-19, so it seems as if supporting a vaccination mandate would be in the best interest of our community.
- **r)** Wuennenberg: I would still consider vaccination status to be a personal choice, but I also agree with Tori in that there is a community aspect to it and I think there should be discussion about how much that should be considered.
- s) Bishop: The COVID-19 vaccination cannot 100% prevent transmission. There is not enough substantial evidence to suggest this.
- t) Barge: If Truman State University does have a vaccination mandate, what would be the consequences of not getting it?
 - i) Bates: We have not discussed a vaccination mandate, so there are no repercussions being discussed.
- **u)** Woods: It's true that COVID-19 vaccination cannot 100% prevent transmission. However, the goal has always been herd immunity; we know that the more people who have the vaccination, the less cases we will see.

- **v)** Rascher: My overarching point I'd like to make about the resolution is that I don't have as many concerns about what I see in the resolution, but I have concerns about what I don't see; what is missing.
- w) Wuennenberg: Regarding your overall comments about vaccine efficacy, there still needs to be a discussion about how this affects others in our community. Also, I don't think that because a majority of students support something means we should automatically support it. We are representing the student body and we need to be considering every perspective, including those who are not in the majority. I still think we need to be considering these motions even if the majority of the student body support them.
- **x)** Kershaw: If you have any further comments, don't just leave them on the document during the meeting. This is the time to physically talk about.
