  - a) Resolution 121.010 D&I Committee Rules Change (Cooper)
    - i) Cooper: There is an advisory board that Shania and I are on for the LGBTQ+ Center. I want it to be in the standing rules that someone from the body will continue to go to the advisory board meeting after we both graduate, or if we are unable to attend.
      - (1) Montúfar: There is a representative from Student Government to be on the committee so it makes sense that we incorporate this in our standing rules. Kennedy and I will possibly have more information about how the representative will serve the committee next weekend.
      - (2) O. Smith: If you want to amend this to say that someone specifically should be on the committee, that is an option.
        - (a) Cooper: I will keep that in mind.
    - ii) First read.
  - **b)** Resolution 121.011 OAF Resolution (Smith)
    - oversees the fees that students pay. It is a substantial amount of money, but specifically the Student Health Center and Information Technology (IT) fees are not controlled by students. OAF was placed in charge of these fees that they aren't knowledgeable of which can lead to some issues. If the fees need to be raised and we are informed of what the fees go to, I don't want OAF to have to come to us if they need help— that isn't fair to them. Sometimes there are student-proposed projects that they fund, but that is fairly rare. We currently don't mention OAF in the standing rules, which means the future President/Vice President may be confused in the future if past administrations don't carry that information on. What I really want to have happen today is to have a discussion on what to do with this information. I will likely table the resolution after this discussion and then come back to it when we have more discussion.
      - (1) Montúfar: I think some of the big points of clarification this resolution raises involves recruiting for the committee. Who would be on this committee? It seems like Business and Accounting should

be more hands-on in this process. It also may be hard to get the students to be involved in the committee. There needs to be more structure in organizing this committee and who will serve on it. The question remains... How will we review these fees? There are factors such as inflation that would go into what the fees should be used for. Another question is... How will we continue this committee, and how can we make this committee the most functional?

- (2) Kershaw: The biggest thing we should figure out is who should be in charge of organizing our student fees. It doesn't seem right that we should be in charge of it because we are one of the groups that should be audited and it doesn't make sense that we should be in charge of it. In regards to health fees, I don't think the University relies on us to have those fees raised, and they're not putting pressure on us to raise them. With the tuition not being capped, we need to be careful about the fees that we do not have control over.
- (3) O. Smith: First, student fees are not covered by scholarships. If the Student Health Center or IT updates, they would just raise tuition to cover it. The breakdown of where tuition money goes makes it hard to see what specific things are funded. Second, there have always been concerns about Student Government being one of the people on OAF because we are also audited.
- (4) Montúfar: Per our last conversation, Dave Rector sent us a breakdown of costs. In the Fall 2019 semester, our health fee covered 31% of operations at the Student Health Center. Now, they cover about 22%. You can see how that can be fairly unstable in the future.
